This Policy is issued on the basis of the information given and declarations made by the Policyholder in the Proposal Form and any information/documentation accompanying the Proposal Form, which is incorporated in the Policy and forms the basis of this Policy. The following terms shall have the meaning assigned to them below, wherever these terms appear in the Policy Document. The singular includes the plural and references to the male include the female where the context so permits.

#### 1. Definitions & Abbreviations:

- a) **"Act"** means the Insurance Act, 1938 (4 of 1938).
- b) **"Age"** means age at last birthday.
- c) **"Appointee"** means a person, as mentioned in the Schedule, to whom the Policy proceeds/benefits will be paid to, in case the Nominee is a Minor on the date of payment.
- d) **"Assignee"** is the individual to whom/institution to which the Assignment is made by the Policyholder.
- e) **"Assignment"** means transfer of rights by the Policyholder in the Policy to another individual/institution that gives the Assignee the rights to receive benefits under the Policy from the date of Assignment, for a consideration or otherwise. Assignment shall be as per Section 38 of the Insurance Act, 1938 as amended from time to time.
- f) **"Business Day"** means days other than holidays where stock exchanges (excluding Muhurat trading day or days on which exchanges are open for testing) with national wide terminals are open for trade or any day declared by IRDAI as business day.
- g) **"Charges"** means the charges applicable to this Policy as detailed in Section 15 and Section 16 below.
- h) **"Claimant" / "Beneficiary"** means the Life Assured (if alive) or Policyholder (if different from the Life Assured) or the Assignee or the Nominee or the legal heirs of Policyholder/

Nominee(s) to whom the benefits under the Policy will be payable.

- i) **"Company/We/Us"** means BAJAJ LIFE INSURANCE LIMITED.
- j) **"Current Assets"** includes cash balance, bank Fixed Deposits (FDs) and Certificate of Deposits (CDs), commercial papers, accrued investment income (not due and due but not received) and other receivables if any.
- k) **"Current Liabilities and Provisions"** includes any amount payable for the investments, the expenses for the brokerage and transaction cost, non-performing assets, Fund Management Charges and any other Charge as approved by the IRDAI including any applicable GST & cess.
- l) **"Customer Information Sheet (CIS)"** is the document provided to the Policyholder along with the Policy Document that explains the basic features of the Policy in simple words.
- m) **"Date of Commencement of Risk"** means the date specified in the Schedule (unless the Policyholder is informed otherwise by the Company) from which the risk cover of the Life Assured commences under the Policy.
- n) **"Date of Surrender"** means the date on which the Company receives the written communication from the Policyholder to surrender the Policy as per Section 9 below.
- o) **"Death Benefit"** means the benefit payable on the death of the Life Assured, as mentioned in the Schedule and calculated in accordance with Section 5a) below.
- p) **"Discontinued Life Policy"** means the Policy wherein the Policyholder surrendered during the Lock-in Period.
- q) **"Discontinued Life Policy Fund"** means a segregated Fund, constituted by the Fund Value of all the Discontinued Life Policies, and is maintained by the Company in accordance with the IRDAI (Insurance Products) Regulations, 2024, and any subsequent modification made therein by the IRDAI. The investment objective of the Fund is, if any, as specified in the IRDAI (Insurance Products) Regulations, 2024, and any subsequent modification made therein by the IRDAI.

- r) **"Discontinuance Value"** has the meaning as per Section 10 below.
- s) **"Endorsement"** means conditions attached/affixed to this Policy incorporating any amendments or modifications agreed to or issued by the Company.
- t) **"Family Benefit"** is an amount that will be added to the Single Premium Fund Value as per the terms and conditions detailed in Section 5d) below, if Family Benefit is available in the Policy and the proportion of benefit is as indicated in the Schedule.
- u) **"Foreclosure"** means an early termination of your Policy as per the details mentioned in Section 26 below.
- v) **"Free Look Period"** means the period in which the Policyholder can choose to terminate the Policy as per the details mentioned in Section 6 below.
- w) **"Fund"** means separately identifiable segregated investment linked fund set up by the Company and specified in the Schedule of Investment Funds as per Section 12)a)v) below.
- x) **"Fund Value"** means sum total of the Single Premium Fund Value and the Top Up Premium Fund Value, if any and the Top Up Premium Fund Value, if any, as applicable in the Policy.
- y) **"Goods and Service Tax (GST)"** means applicable tax which is charged based on the type of policy/communication address of the Policyholder as stated in the Schedule. The rates charged may change subject to change in rate and/or the state mentioned in the communication address of the Policyholder as on date of adjustment.
- z) **"GST"** means Goods and Service Tax.
- aa) **"Grace Period"** not applicable under the Policy.
- bb) **"Guaranteed Benefit"** is 105% of the all the Single Premium plus Top up Premiums (as applicable in the Policy) received under the Policy until the date of death of the Life Assured.
- cc) **"IRDAI"** means the Insurance Regulatory and Development Authority of India.
- dd) **"Life Assured"** means the person named as the Life Assured in the Schedule whose life is assured under this Policy, and also can refer to the Primary Life Assured and the Secondary Life Assured to the extent applicable.
- ee) **"Lock-in Period"** means the period of five (5) consecutive completed Policy Years from the Policy Commencement Date, during which period the proceeds of the Policy cannot be paid by the Company to the Policyholder, except in the case of death.
- ff) **"Loyalty Benefit"** is an amount that will be added periodically to the Single Premium Fund Value (as applicable in the Policy), as detailed in Section 5b) below.
- gg) **"Maturity Benefit"** is the benefit payable on the Maturity Date. The details are as given in Section 5a)ii) below
- hh) **"Maturity Date"** means the date specified in the Schedule on which the Maturity Benefit shall become payable to the Policyholder.
- ii) **"Minor"** is a Life Assured or Nominee who is aged less than 18 years.
- jj) **"Monthly Due Date"** means the date corresponding numerically with the Policy Commencement Date in each subsequent month.
- kk) **"Nomination"** means the process of appointing person(s) to receive Policy proceeds/benefits on the death of the Life Assured (in a Policy where the Life Assured is also the Policyholder). Nomination shall be as per Section 39 of the Insurance Act, 1938, as amended from time to time.
- ll) **"Nominee"** means the person/s specified in the Schedule who has/have been nominated in writing to the Company by the Policyholder, who is entitled to receive the Death Benefits under the Policy. If the Life Assured is Minor, then, the Nominee details are to be provided once he becomes major.
- mm) **"Policy"** means the arrangements established by the Policy Document.
- nn) **"Policy Anniversary"** means the date corresponding numerically with the Policy Commencement Date in each subsequent year during the Policy Term.
- oo) **"Policy Commencement Date"** means the date of commencement of the Policy, as specified in the Schedule.
- pp) **"Policy Document"** means this policy wording, the Schedule (which is attached to and forms part of this Policy and includes any Annexure or Endorsement to it and if

- qq)** **“Policyholder”** means the adult person named in the Schedule who has concluded the Policy with the Company.
- rr)** **“Policy Term”** means the period between the Policy Commencement Date and the Maturity Date, as specified in the Schedule.
- ss)** **“Policy Year”** means a period of one (1) year commencing from the Policy Commencement Date or a Policy Anniversary thereof.
- tt)** **“Premium Allocation Rate”** means the rate net of the Premium Allocation Charge [as per Section 15d) below] and any GST & cess (as applicable) will be applied to the Single Premium and Top Up Premium (if any) received to arrive at the amount to be allocated in the Unit Account in respect of any Single and or Top Up Premium paid by the Policyholder.
- uu)** **“Premium Paying Term (PPT)”** is one (1) year.

- yy)** **“Primary Life Assured”** means the person named as the Life Assured in the Schedule under Primary Life Assured, and whose life is assured under this Policy.
- zz)** **“Proposal Form”** means the Policyholder’s statements in the proposal for this Policy submitted by or on behalf of the Policyholder along with any other information or documentation provided to the Company prior to inception of the Policy.
- aaa)** **“Proposer”** means an individual who has applied to buy the Policy. The Proposer becomes a Policyholder on the issuance of the Policy.
- bbb)** **“Return Of Allocation Charge (ROAC)”** is an amount [equal to the total of all Premium Allocation Charges (excluding any GST & cess, if any) charged under the Policy] that will be added to the Single Premium Fund Value (as applicable in the Policy) as detailed in Section 5 b) i) below.
- ccc)** **“Return Of Mortality Charge (ROMC)”** is an amount [equal to the total of all Mortality Charges (excluding any Extra Premium and/or GST & cess, if any) charged under the Policy] that will be added to the Single Premium Fund Value or the Top Up Premium Fund Value (as applicable in the Policy) as detailed in Section 5 c) below.
- ddd)** **“Rider”** means an add-on or additional benefit, which the Policyholder can opt for along with the base Policy. The Rider/s that is/are taken in the Policy are mentioned in Schedule. The benefits and terms & conditions of the Rider will be part of the Policy Document, if any taken in the Policy.
- eee)** **“Schedule”** means a document which is attached to and forms a part of this Policy containing specific details of the Policy.
- fff)** **“Secondary Life Assured”** means the person named as the Life Assured in the Schedule under Secondary Life Assured, and whose life is assured under this Policy.
- ggg)** **“Single Premium”** means the amount payable by the Policyholder at the Policy Commencement Date, as per the amount specified in the Schedule.
- hhh)** **“Single Premium Fund Value”** is equal to the total Units in respect of the Single Premium received under this Policy multiplied by the respective Unit Price/NAV on the relevant Valuation Date.
- iii)** **“Sum Assured”** is the amount as specified in the Schedule or such amounts as set out in a subsequent Endorsement issued by the Company upon the Policyholder choosing any option available under the Policy. The Sum Assured prevailing on the date of death is known as Prevailing Sum Assured and will be used to determine the Death Benefit under the Policy.
- jjj)** **“Surrender Value”** means the amount payable to the Policyholder on surrender as per Section 9 below.
- kkk)** **“Top Up Premium”** means any additional premium paid voluntarily by the Policyholder (other than Single Premium) under the Policy in accordance with Section 11g) below
- lll)** **“Top Up Premium Fund Value”** is equal to the total Units in respect of Top Up Premiums, if any received under this Policy multiplied by the respective Unit Price/NAV on the relevant Valuation Date.

**mmm) "Total Premiums Paid"** means the sum of all the Single Premium received and Top Up Premiums, if any, received till date, excluding any Rider premium, any extra premium on rider and taxes.

**nnn) "Top Up Sum Assured"** means the additional Sum Assured which is referred-to, to determine the Death Benefit payable after the Date of Commencement of Risk and calculated in accordance with Section 11g) below. It is the Top Up Sum Assured as it prevails as on the date of death.

**ooo) "UIN"** means the Unique Identification Number allotted to this Plan as specified in Schedule above.

**ppp) "Unit"** means a proportionate part of the underlying segregated linked Fund created to determine the Unit Price/NAV.

**qqq) "Unit Account"** means an individual account created and administered by the Company for a Policy and consisting of Units in one or more Funds, which are valued in reference to the Unit Price/NAV of respective Fund.

**rrr) "Unit Price/NAV"** means the value per Unit calculated in Rupees as follows:

Unit Price/NAV = Market value of investment held by the Fund plus value of Current Assets less value of Current Liabilities and Provisions, if any, divided by number of Units existing on Valuation Date. This calculation will be done before creation / redemption of Units.

**sss) "Valuation Date"** refers to the date when the Unit Price/NAV of the Fund is determined.

**ttt) "w.r.t"** means with respect to.

Loyalty Benefits, Maturity Benefit and Surrender Value as mentioned below.

d) The Policy also provides Return of Mortality Charge, as detailed in Section 5c) below.

e) The Policy enables the Policyholder to participate only in the investment performance of the Funds to the extent of allocated Units and does not in any way confer any right and shall not be deemed to confer any right whatsoever on the Policyholder or the Life Assured to otherwise share in the assets, the profits or surplus of the business of the Company.

f) The Policy issued to a Life Assured who is less than the Age of 18 years shall mature only after the Life Assured has attained the Age of 18 years. In such Policies, no partial withdrawals (systematic or non-systematic shall be allowed before the Life Assured attains the Age of 18 years.

g) If the Life Assured is a Minor at the Policy Commencement Date, on attaining the Age of majority, i.e., 18 years, the Policy will vest on Life Assured. Thereafter, the Life Assured shall become the Policyholder who will then be entitled to all the benefits and subject to all liabilities of the Policy

### 3. Single Premium

a) If the Policy is a Single Premium Policy then the Single Premium specified in the Schedule must be received in full at the Policy Commencement Date.

b) The Company will not accept as the Single Premium, any amount less than Single Premium amount due.

### 4. Premium Allocation

Units are allocated under the Policy based on the amount of Single Premium and Top Up Premium if any, received, the Premium Allocation Rate and the Unit Price/NAV of each Fund on the date of allocation. Such allocations may be made up to 1/10,000th of a Unit or such other fraction as the Company may decide from time to time.

## Part C

### 2. Policy Description

a) This is a non-participating, life, individual, Single Premium Unit-Linked savings insurance plan.

b) The plan provides three (3) variants; Variant 1 – Wealth, Variant 2 – Child Wealth and Variant 3 – Joint Life Wealth. The Variant chosen in the Policy is Variant 3 – Joint Life Wealth. The Variant, once chosen, cannot be changed during the Policy Term.

c) The Policy provides Death Benefit,

### 5. Policy Benefits

#### a. i) Death Benefit

- (1) On the date of intimation of the first death out of the Primary Life Assured and the Secondary Life Assured, after the Date of Commencement of Risk and before the Maturity Date, provided the Policy is in-force, the Company shall increase:
  - (a) The Single Premium Fund Value to 1.25 times the Single Premium, if the Single Premium Fund Value is found to be lower, as on that date of intimation of death and
  - (b) The Top Up Premium Fund Value to 1.25 times the Top Up Premium, if the Top Up Premium Fund Value is found to be lower, as on that date of intimation of death
  - (c) In Sub-Section (a) & Sub-Section (b) above, if the Single Premium Fund Value and/or Top Up Premium Fund Value is/are already higher than 1.25 times the Single Premium and/or 1.25 times the Top Up Premium, respectively, then, no amount will be added to the respective Fund Values.
  - (d) The amount, if any, will only be added to the respective Fund Values, and no amount will be paid out to the Policyholder.
  - (e) The Policy will be continued only on the surviving Life Assured with all the other Benefits under the Policy.

### b) Wheel of Life Portfolio Strategy II

- This strategy provides the Policyholder with “Years to maturity based portfolio management”.
- The Policyholder can opt for this Portfolio Strategy at the commencement of the Policy or can switch to this Portfolio Strategy at any subsequent Policy Anniversary by giving a written notice to the Company 30 days in advance.
- If the Policyholder has opted for this Portfolio Strategy at the commencement of the Policy, the Single Premium and the Top Up Premium, if any, would be allocated in the Funds mentioned (namely Equity Growth Fund II, Accelerator Mid-Cap Fund II, Bond Fund & Liquid Fund) in the proportion as mentioned in the table below, depending on the outstanding years to maturity.
- If the Policyholder has switched to this Portfolio Strategy at any subsequent Policy Anniversary:
  - The Company will reallocate the Single Premium Fund Value and Top Up Premium Fund Value among various Funds in the proportion mentioned in the table below depending on the outstanding years to maturity of the policy.
  - The Top Up Premiums, if any paid in that particular Policy Year will also be allocated in the same proportion.

- (2) Under this Portfolio Strategy, Single Premium and Top Up Premiums, if any, (after any Premium Allocation Charge) will be allocated between two Funds, Equity Growth Fund II (an equity oriented fund), and Bond Fund (a debt oriented fund), in a 75%: 25% proportion.
- (3) The Fund Value proportions may subsequently get altered due to market movements. On the pre-defined trigger event mentioned below, the Funds will be re-balanced or reallocated.
- (4) The trigger event is a 15% upward or downward movement in Unit Price/NAV of Equity Growth Fund II or in the Unit Price/NAV of the Bond Fund, since the previous rebalancing or from the Unit Price/NAV at the inception of the Policy, whichever is later.
- (5) On the occurrence of the trigger event of 15% upward movement w.r.t.:
  - (a) The Equity Growth Fund II, any value of Units in Equity Growth Fund II which is in excess of three (3) times the value of Units in Bond Fund is considered as gains and is switched to the Liquid Fund - by redemption of appropriate Units from Equity Growth Fund II.
  - (b) The Bond Fund, any value of Units in Bond Fund which is in excess of three (3) times the value of Units in Equity Growth Fund II is considered as gains and is switched to the Liquid Fund - by redemption of appropriate Units from Bond Fund.
  - (c) This ensures that such gains are capitalized and protected from future equity market fluctuations, while maintaining the asset allocation between Equity Growth Fund II and Bond Fund at 75%:25%.

- (6) On the occurrence of the trigger event of 15% downward movement w.r.t. the Equity Growth Fund II or the Bond Fund, Units in the Liquid Fund, if any, will be switched to the Equity Growth Fund II and the Bond Fund such that, after transfer, the ratio of the value of Units in the Equity Growth Fund II to that in the Bond Fund is restored to 75%:25%, to the extent possible and subject to availability of Units in the Liquid Fund.
- (7) The Policyholder can switch out of this Portfolio Strategy at any Policy Anniversary by giving a written notice to the Company 30 days in advance.

### d) Auto Transfer Portfolio Strategy

- i) The Policyholder can opt for this Portfolio Strategy at the commencement of the Policy or can switch to this Portfolio Strategy at any subsequent Policy Anniversary by giving a written notice to the Company 30 days in advance.
- ii) Under this Portfolio Strategy, Single Premium and the Top Up Premium, if any, (after any Premium Allocation Charge) will be allocated in the Bond Fund and/or Liquid Fund, as decided by the Policyholder.
- iii) At the start of each monthly anniversary of the Policy, a proportion [as mentioned in the below table] of the Fund Value in the Bond Fund and/or Liquid Fund as on that date will be switched to the other Fund/s (available in the product) as specified by the Policyholder
- iv) The proportion to be switched will depend upon the number of outstanding months till the next premium due date. The proportion would be mentioned as below:

- vi) The Policyholder can switch out of this Portfolio Strategy at any Policy Anniversary by giving a written notice to the Company 30 days in advance.

### e) Capital Preservation-Oriented Strategy

- (1) This strategy can be opted only at the inception of the Policy. This strategy can be opted only if Policy Term is at least 10 years, and the minimum difference between the Policy Term and Premium Paying Term is at least 5 years.
- (2) The objective of the strategy is to optimise risk and return, by investing across five (5) pre-determined Funds, which are a mix of very high to low risk funds, in such a way that the monies invested over the years along with the accumulated returns are subjected to lesser market volatility, in the years closer to maturity. However, the strategy does not provide any minimum guaranteed maturity benefit.
- (3) Under this strategy, at the commencement of the Policy, the Single Premium and the Top Up Premium, if any, would be allocated in the Funds mentioned (namely Equity Growth Fund II, Accelerator Mid-Cap Fund II, Pure Stock Fund II, Bond Fund & Liquid Fund) in the proportion as mentioned in the table below.

- (8) In case of partial withdrawal, the withdrawal of Units from each Fund will be done in the same proportion as the value of the Units held in that Fund as on date of withdrawal. The Policyholder will not have any choice to opt the Fund(s) from which the partial withdrawal of Units is to be done.

### 13. Force Majeure Condition

- a) As per IRDAI (Insurance Product) Regulation 2024, Schedule I, Clause 2, Section A, sub-Section v, the company will declare a 'Single' Unit Price or Net Asset Value (NAV) for each segregated fund on a day-to-day basis.
- b) The company specifies that, in

the event of certain force majeure conditions, the declaration of Unit Price or NAV on a day-to-day basis may be deferred and could include other actions as a part of investment strategy (e.g. taking exposure of any Segregated Fund (SFIN<sup>#</sup>) up to 100% in Money Market Instruments [as defined by Regulations 1(8) under Schedule III, Part-I of the IRDAI (Actuarial, Finance and Investment Function of Insurers) Regulations, 2024])

- c) The Company shall value the Funds (SFIN) on each day for which the financial markets are open. However, the Company may value the SFIN less frequently in extreme circumstances external to the Company i.e. in force majeure events, where the value of the assets is too uncertain. In such circumstances, the Company may defer the valuation of assets for up to 30 days until the Company is certain that the valuation of SFIN can be resumed.
- d) The Company shall inform IRDAI of such deferment in the valuation of assets. During the continuance of the force majeure events, all request for servicing the policy including policy related payment shall be kept in abeyance.
- e) The Company shall continue to invest as per the Fund mandates as described in Section 12a)v) above. However, the Company shall reserve its right to change the exposure of all or any part of the Fund to Money Market Instruments [as defined under Regulations 1(8) under Schedule III, Part-I of the IRDAI (Actuarial, Finance and Investment Functions of Insurers) Regulations, 2024] in circumstances mentioned under points (a and b) above. The exposure of the Fund as per the Fund mandates as described in Section 12a) v) above shall be reinstated within reasonable timelines once the force majeure situation ends.
- f) Some examples of such circumstances [in Sub-Section a) & Sub-Section b) above] are:
  - i) When one or more stock exchanges which provide a basis for valuation

of the assets of the Fund are closed otherwise than for ordinary holidays.

- ii) When, as a result of political, economic, monetary or any circumstances out of the control of the Company, the disposal of the assets of the Fund are not reasonable or would not reasonably be practicable without being detrimental to the interests of the continuing Policyholders.
- iii) In the event of natural calamities, strikes, war, civil unrest, riots and bandhs.
- iv) In the event of any force majeure or disaster that affects the normal functioning of the Company.
- g) In such an event, an intimation of such force majeure event shall be uploaded on the Company's website for information.

### 14. Fund Provisions

#### a. Purpose of the Funds

The Company has established the above Funds from which it will make payment of a part of or all of the benefits payable under this Policy.

#### b. Investment of the Funds

- i) The selection of the underlying investments of each Fund established by the Company and the valuation of assets to which it is referenced shall be such as the Company, in its absolute discretion, may from time to time determine provided it satisfies the investment objectives set out in Section 12 and 14 above and any IRDAI Regulations as applicable from time to time. It is further provided that the assets of each Fund may comprise such proportion as the Company may determine including un-invested cash or any other assets whether or not this produces income.
- ii) All assets relating to the Fund shall be and shall remain in the absolute beneficial ownership of the Company. There is no trust created,

### 15. Charges

All Charges mentioned below will be subject to the applicable GST & cess.

#### a. Mortality Charge

- i) The Mortality Charge will be deducted at the rate as applicable to the attained Age and gender of the Life Assured, on the Date of Commencement of Risk by cancellation of units at the prevailing Unit Price and on each subsequent Monthly Due Dates. The Mortality Charge may vary from Policy Year to Policy Year (and during the settlement period, if applicable) according to the attained Age of the Life Assured at the time of deduction of the same.
- ii) The Mortality Charge per thousand Sum at Risk is given in Annexure I-A.
- iii) The Mortality Charge is applied on the Sum at Risk under the Policy.
- iv) Mortality Charge would only be charged up to the date of death as applicable and is guaranteed throughout the Policy term

### 18. Non-Participation in Profits

The Policy enables the Policyholder to participate only in the investment performance of the Funds and shall not be deemed to confer any right share in the assets, the profits or surplus of the business of the Company.

### 19. Fund Amendments

After taking prior approval from IRDAI, the Company may carry out addition, closure or merger of the Funds available under this Policy.

### 20. Unit Statement

The Company will issue a Unit Statement to the Policyholder at every Policy Anniversary or on the happening of any Unit transaction under the Policy except due to deduction of the Charges.

### 21. Suicide Exclusion

### Annexure AA

#### Section 38 of Insurance Act, 1938, as amended from time to time – Assignment and Transfer of Insurance Policies

Assignment or transfer of a Policy should be in accordance with section 38 of the Insurance Act, 1938, as amended from time to time. The extant provisions in this regard are as follows:

1. This Policy may be transferred / assigned, wholly or in part, with or without consideration.
2. An assignment may be effected in a Policy by an endorsement upon the Policy itself or by a separate instrument under notice to the Company.
3. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
4. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
5. The transfer of assignment shall not be operative as against the Company until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy thereof certified to be correct by both transferor and transferee or their duly authorized agents have been delivered to the Company.
6. Fee to be paid for assignment or transfer can be specified by the IRDAI through Regulations.
7. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the Company of duly receiving the notice.
8. If the Company maintains one or more places of business, such notices shall be delivered only at the place where the Policy is being serviced.
9. The Company may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is (a) not bona-fide or (b) not in the interest of the Policyholder / Life Assured or (c) not in public interest or (d) is for the purpose of trading of the Policy.
10. Before refusing to act upon endorsement, the Company should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of Policyholder giving a notice of transfer or assignment.
11. In case of refusal to act upon the endorsement by the Company, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Company.
12. The priority of claims of persons interested in the Policy would depend on the date on which the notices of assignment or transfer is delivered to the Company; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to IRDAI.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
  - a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
  - b. where the transfer or assignment is made upon condition that
    - i. the proceeds under the Policy shall become payable to Policyholder or Nominee(s) in the event of assignee or transferee dying before the Life Assured OR
    - ii. the Life Assured surviving the Policy TermSuch conditional assignee will not be entitled to obtain a loan on Policy or surrender the Policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.
14. In other cases, the Company shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
  - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
  - b. may institute any proceedings in relation to the Policy
  - c. obtain loan under the Policy or surrender the Policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
15. Any rights and remedies of an assignee or transferee of the Policy under an assignment or transfer effected before commencement of The Insurance Laws (Amendment) Act, 2015 shall not be affected by this section.

### **Annexure BB**

#### **Section 39 of the Insurance Act, 1938, as amended from time to time – Nomination by Policyholder**

Nomination of a life insurance Policy is as below in accordance with section 39 of the Insurance Act, 1938, as amended from time to time. The extant provisions in this regard are as follows:

1. The Policyholder of a life insurance Policy on his own life may nominate a person or persons to whom money secured by the Policy shall be paid in the event of his death.
2. Where the Nominee is a Minor, the Policyholder may appoint any person to receive the money secured by the policy in the event of Policyholder's death during the Minority of the Nominee. The manner of appointment to be laid down by the Company.
3. Nomination can be made at any time before the maturity of the Policy.
4. Nomination may be incorporated in the text of the Policy itself or may be endorsed on the Policy communicated to the Company and can be registered by the Company in the records relating to the Policy.
5. Nomination can be cancelled or changed at any time before Policy matures, by an endorsement or a further endorsement or a will as the case may be.
6. A notice in writing of change or cancellation of Nomination must be delivered to the Company for the Company to be liable to such Nominee. Otherwise, Company will not be liable if a bona-fide payment is made to the person named in the text of the Policy or in the registered records of the Company.
7. Fee to be paid to the Company for registering change or cancellation of a Nomination can be specified by the IRDAI through Regulations.
8. On receipt of notice with fee, the Company should grant a written acknowledgement to the Policyholder of having registered a Nomination or cancellation or change thereof.
9. A transfer or assignment made in accordance with section 38 of Insurance Act, 1938, as amended from time to time, shall automatically cancel the Nomination except in case of assignment to the Company or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the Nomination will not get cancelled to the extent of Company's or transferee's or assignee's interest in the Policy. The Nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any Policy of life insurance shall not be affected by the Nomination.
11. In case of Nomination by Policyholder whose life is insured, if the Nominees die before the Policyholder, the proceeds are payable to Policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case Nominee(s) survive the person whose life is insured, the amount secured by the Policy shall be paid to such survivor(s).
13. Where the Policyholder whose life is insured nominates his/her (a) parents or (b) spouse or (c) children or (d) spouse and children or (e) any of them, the Nominees are beneficially entitled to the amount payable by the Company to the Policyholder unless it is proved that Policyholder could not have conferred such beneficial title on the Nominee having regard to the nature of his title.
14. If Nominee(s) die after the Policyholder but before his share of the amount secured under the Policy is paid, the share of the expired Nominee(s) shall be payable to the heirs or legal representative of the Nominee(s) or holder of succession certificate of such Nominee(s).
15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance Policies maturing for payment after the commencement of The Insurance Laws (Amendment) Act, 2015 .
16. If Policyholder dies after maturity but the proceeds and benefit of the Policy has not been paid to him because of his death, his Nominee(s) shall be entitled to the proceeds and benefit of the Policy.
17. The provisions of section 39 of the Insurance Act, 1938, as amended from time to time, are not applicable to any life insurance Policy to which section 6 of Married Women's Property Act, 1874, applies or has at any time applied except where before or after The Insurance Laws (Amendment) Act, 2015, a Nomination is made in favour of spouse or children or spouse and children whether or not on the face of the Policy it is mentioned that it is made under section 39 of the Insurance Act, 1938, as amended from time to time. Where Nomination is intended to be made to spouse or children or spouse and children under section 6 of MWP Act, it should be specifically mentioned on the Policy. In such a case only, the provisions of section 39 of Insurance Act, 1938, as amended from time to time, will not apply.

### **Annexure CC**

#### **Section 45 of the Insurance Act, 1938, as amended from time to time – Policy shall not be called in question on the ground of mis-statement after three years**

Provisions regarding Policy not being called into question in terms of section 45 of the Insurance Act, 1938, as amended from time to time are as follows:

1. No Policy of life insurance shall be called in question on any ground whatsoever after expiry of three (3) years from (a) the Policy Commencement Date or (b) the Date of Commencement of Risk or (c) the date of latest revival of the Policy or (d) the Date of Commencement of Rider; whichever is later.
2. On the ground of fraud, a Policy of life insurance may be called in question within three (3) years from (a) the Policy Commencement Date or (b) the Date of Commencement of Risk or (c) the date of latest revival of the Policy or (d) the Date of Commencement of Rider; whichever is later.  
For this, the Company should communicate in writing to the Company or legal representative or Nominee or assignees of Policyholder, as applicable, mentioning the ground and materials on which such decision is based.
3. Fraud means any of the following acts committed by Life Assured or Policyholder or by his agent, with the intent to deceive the Company or to induce the Company to issue the life insurance Policy:
  - a. The suggestion, as a fact of that which is not true and which the Life Assured or Policyholder does not believe to be true,
  - b. The active concealment of a fact by the Life Assured or Policyholder having knowledge or belief of the fact,
  - c. Any other act fitted to deceive, and,
  - d. Any such act or omission as the law specifically declares to be fraudulent.
4. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the Life Assured or Policyholder or his agent keeping silence to speak, or silence is equivalent to speak.
5. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Life Assured or Policyholder / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such misstatement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the Policyholder, if alive, or beneficiaries.
6. Life insurance Policy can be called in question within three (3) years on the ground that any statement of or suppression of a fact material to expectancy of life of the Life Assured or Policyholder was incorrectly made in the Proposal Form or other documents, basis which Policy was issued or revived, or Rider issued. For this, the Company should communicate in writing to the Life Assured or Policyholder or legal representative or Nominee or assignees of Policyholder, as applicable, mentioning the ground and materials on which decision to repudiate the Policy of life insurance is based.
7. In case repudiation is on ground of misstatement and not on fraud, the premium(s) collected on Policy till the date of repudiation shall be paid to the Policyholder or legal representative or Nominee or assignees of Policyholder, within a period of 90 days from the date of repudiation.
8. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the Company. The onus is on Company to show that if the Company had been aware of the said fact, no life insurance Policy would have been issued to the Policyholder.
9. The Company can call for proof of age at any time if he is entitled to do so and no Policy shall be deemed to be called in question merely because the terms of the Policy are adjusted on subsequent proof of age of Life Assured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
